TERMS AND CONDITIONS

1. Whilst every care is taken of the dogs undergoing treatment and in the maintenance of the water and equipment, all dogs receive hydrotherapy treatment entirely at their owner's risk.
2. All treatment courses, including those to be part of an insurance claim, must be paid for in advance. Individual sessions must be paid for on the day of treatment.
3. Sessions fees will be **charged in full** if an appointment is broken or cancelled without 24 hours' notice.
4. Dogs will not be treated without the prior authorisation of their veterinary surgeon.
5. Dogs with infectious or contagious conditions, such as ear, eye or skin infections, will not be treated. Owners are advised to cancel all appointments with at least 24 hours' notice, until the condition is clear. Normal cancellation conditions will apply.
6. Bitches in season will not be able to attend session until their season has finished.
7. [Tall Barn K9 Hydrotherapy Centre](#) will require sight of the dog's vaccination certificate prior to commencement of treatment. Or we require a signed disclaimer from owner.
8. Owners are required to notify [Tall Barn K9 Hydrotherapy centre](#) if, during treatments, the dog's injury or condition worsens, or if the veterinary surgeon advises that the treatment is to be stopped or suspended.
9. [Tall Barn K9 Hydrotherapy centre](#) reserves the right to refuse treatment of any dog.
10. Owners are requested not to bring dogs other than those being treated to [Tall Barn K9 Hydrotherapy centre](#).
11. Owners are requested not to feed their dogs for at least 3 hours before attending an appointment, and to ensure the dog has done its ablutions before arriving. A surcharge of £75 will be made for dogs that defecate in the pool.
12. When not undergoing treatment, all dogs must be kept under control.
13. It is the owner's responsibility to pick up after their dogs, whilst on the premises and its surrounding environment. Bags are available on request.
14. [Tall Barn K9 Hydrotherapy centre](#) cannot be held responsible for any loss or damage to vehicles or personal property, howsoever occasioned whilst on the premises.
